Dear Speaker Hammett:

This letter is to confirm that you, Seth Hammett, have agreed to be interviewed by federal law enforcement agents and Government attorney(s). The following conditions will apply during the interview:

- 1. You acknowledge that your decision to grant this interview and to cooperate with law enforcement agents and Government attorney(s) is entirely voluntary, and is not a result of coercion, threats or intimidation of any kind.
- 2. You will be informed and understand that you may terminate the interview at any time or decline to answer any question asked. You are free to consult with any legal counsel of your own choosing, who shall have the right to be present throughout the interview.
- 3. The Government agrees that no statement you make during the interview(s) will be used to incriminate you unless the Government determines that you have intentionally provided false or misleading information. The Government may also use the information obtained in the interview(s) to pursue any investigation if violations of federal criminal statutes and/or to bring a prosecution against individuals and entities implicated by you.
- 4. This letter does not confer any immunity upon you in the event that evidence is acquired, independent of this interview, which implicates you in any criminal activity.
- 5. The Government agrees that you will not be deemed to have waived your Fifth Amendment rights by consenting to the interview(s).

If these conditions are satisfactory to you, indicate your agreement to them by signing the acknowledgment below.
